Investigative Report: Thousands of residential plots stand empty in the Bedouin towns of the Negev, as hundreds of millions shekels of Israeli taxpayers' hard- earned cash goes down the drain

Regavim exposed the scandalous waste of public resources that have been poured into developing residential plots for resettlement of Israeli Bedouin in the Negev over the past 20 years. Rather than protecting precious land reserves in southern Israel, the government has squandered monetary and land resources, whitewashed and “legalized” the sprawl of illegal squatters’ camps - costing the Israeli public hundreds of millions of shekels and thousands of dunams of precious land. Arab squatters take over an archaeological site and turn it into a private residence

We demanded that the Civil Administration evict the squatters who have taken over the archaeological site at Khirbet Parsin. After we documented the squatters carrying out construction work that was destroying priceless artifacts dating back thousands of years, we applied massive pressure on the Civil Administration, and inspectors were finally dispatched to the site. They impounded some of the construction materials and equipment and uprooted some of the trees that had been planted by the squatters as a means of staking a claim to the property. We exposed how the Palestinian Authority exploited the corona lockdown to dump hundreds of truckloads of untreated waste into an abandoned quarry in the Binyamin region. In response to our demand for enforcement action, the authorities claimed that the dumping had been stopped – but we won’t give up the fight until the mountain of garbage is removed and the criminals who created it are prosecuted to the full extent of the law. Countless wrecks had been piling up for years at an illegal automotive scrapyard near Bir Zeit, polluting topsoil and groundwater with untreated effluents and automotive waste.
