Mohammad Abu Alqiyian's murderous rampage in Beer Sheva [didn't come as a surprise](#) to Regavim, or to anyone who's [read our publications](#). For 16 years we've been studying the Negev and sounding the alarm: Illegal squatters' camps and rampant polygamy are breeding violence, extremism and a complete breakdown of social and civic norms in the Bedouin sector.

After months of deliberation, the High Court of Justice issued a conditional order in Regavim’s latest Khan al Ahmar petition: The state has 120 days to defend its failure to fulfill the commitment given in this case some three years ago (!) to enforce the law “soon.” The very fact that Regavim has been forced to petition the High Court over and over to force the government to uphold Israel’s Construction and Planning Law is beyond unacceptable – it’s a downright disgrace. In the past year alone, the Palestinian Authority submitted dozens of planning requests to expand villages in Area C. These requests have been submitted by local councils and the like – despite the clear stipulation in Jordanian law, which is still in force in this region, that plans of this kind must be submitted by the High Council for Planning and the legal owners. We submitted an official objection to the zoning commission regarding the expansion of Umm al Fahm that will include “legalizing” 3000 illegally-built units. To alleviate Israel’s housing crisis, a special committee was established, which places particular emphasis on Israeli Arab cities. When we discovered that Special Committee Recommendation 1077 will whitewash thousands of existing illegal units rather than creating real solutions for the housing shortage, we submitted a legal objection to the court. Despite our unrelenting efforts, the government passed the Five Year Plan for the Negev without including an enforcement framework. This significantly weakens law enforcement authorities and their ability to prevent illegal construction and the further sprawl of squatters’ camps that are consuming our land reserves in the Negev. 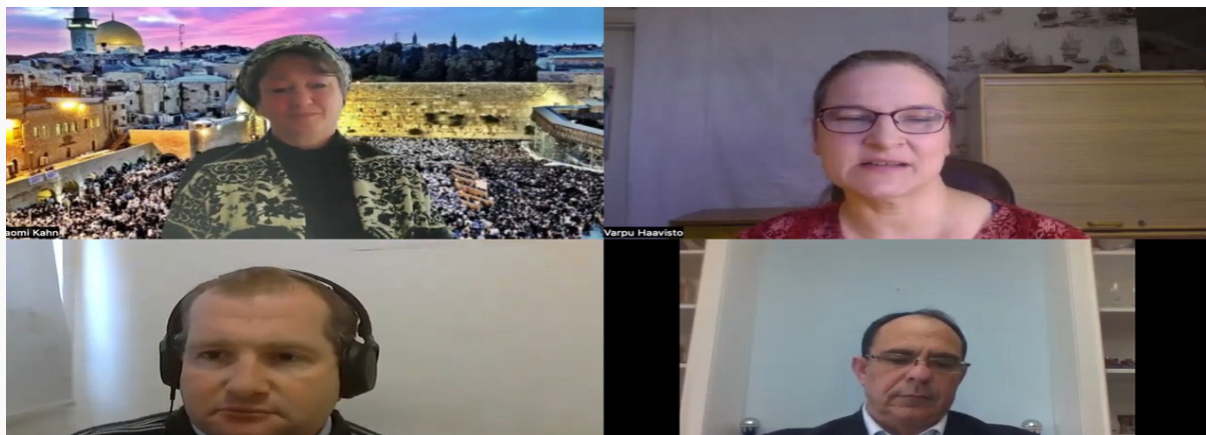
We joined other activists and Zionist organizations in a conference organized by
