Summing up this past year is no easy task. It is difficult to sum up a year that has left so many loose ends and unresolved issues, with no clear end in sight. The year began with heartbreak: 1,200 innocent souls were murdered on October 7, the first day of the war - each one of them, an entire world of family, friends, and unfulfilled dreams. The tragic toll did not stop there, as hundreds of soldiers gave their lives in a battle whose end is yet unknown. Our brothers and sisters, taken hostage, are both so near and so far. Communities in the western Negev have been shattered and residents of northern Israel have been uprooted, all contributing to the weight on our hearts that we continue to bear.

"Man cries out for what he," wrote Meir Ariel, encapsulating in his sharp words the emotions we all feel. Yet this cry also symbolizes a deeper national awakening – a return to our shared values of Judaism, Zionism, and the bond between our People and our Land. The Swords of Iron War has deepened that connection, drawing us back to our roots. It's a stark reminder that physical barriers and fences cannot fully protect us from the lurking dangers, and that true security stems not only from military strength but from a shared sense of belonging and home.

May the year with its curses end, and a new year with its blessings begin.

Where Did the Rocket Siren Catch the Knesset Members?

Amid the heavy rocket barrages targeting northern communities and just before the escalation in fighting against the terrorist organization Hezbollah, we traveled to Merom HaGalil, Kiryat Shmona, and Safed with members of the Knesset's Land of Israel Caucus and media representatives. We met with local leaders and residents to understand their immediate needs and offer support to the communities that have been on the front lines for over a year. The visit received widespread coverage in Israel and abroad, in **Hebrew, English, French** - even **Chinese!**



Raising awareness of the threat to Israel's Seamline communities

This month, we conducted additional tours along the seamline, hosting MK Sharren Haskel, journalists and media influencers. The tour, spanning both sides of the security barrier, from Rosh HaAyin and the southern Sharon region to Samaria, highlighted the findings of [Regavim's report](#), released in the early days of the Swords of Iron War, on the PA conquest of the seam line. The tour enabled residents of threatened communities to describe their experiences, and included visits to observation points on both sides of the fence, exploring security challenges and environmental issues.

For the first time, Regavim hosted a dedicated tour for Knesset Members in East Jerusalem. Yehuda Noam, Regavim's Jerusalem Field Coordinator, illustrated the challenges to Israeli governance and land use policy in the capital, highlighting the geographic, strategic and historic connection between the Ma'ale Adumim region, the Judean Desert and the heart of Jerusalem. The Stockade and Minaret case comes before the court

Two years ago, we uncovered and closely monitored the phenomenon of illegal mosque minarets rapidly appearing in the Bedouin communities of the Negev, symbolizing the lack of governance and the alarming trend of radicalization in the region. Now, we have taken this issue to court: our petition was submitted before the holiday recess. Stay tuned for updates!



INFURIATING! Why was Regavim's petition dismissed?

Israel's High Court of Justice has a very forgiving attitude toward the Civil Administration's failure to protect our national resources in Judea and Samaria. It has a very forgiving attitude toward the Arabs of Judea and Samaria who build illegal structures and steal Israeli state land. But the High Court runs out of patience when it comes to IDF reservists.


The High Court dismissed Regavim's petition against construction of a new neighborhood of luxury villas on the outskirts of the hostile Arab village of Qarawat Bani Hassan in Samaria - a neighborhood that threatens the Jewish community of Havat Yair; in fact, the Arabs used the new neighborhood's structures as a base for terrorism, even before construction was completed: Havat Yair was shot at by their soon-to-be-neighbors.

And why was our petition dismissed? Because our response was delayed - which we anticipated, and is precisely why we notified the court in advance that our staff had been called up for extended emergency military duty.

Shameful.
