These pages are another opportunity to mourn together, and to salute those who have made the ultimate sacrifice.

Despite it all, it was important to us to share a timely report on this year's activities. As 2024 winds down and Hannukah approaches, we wanted this report to bring light and encouragement to our friends and partners.

Since its founding 19 years ago, Regavim has dedicated its efforts to shaping Zionist land use policy in Israel. This is not a goal that we expected to achieve overnight. The change we seek is necessarily the result of many years of hard work -professional, constant and sometimes Sisyphean tasks that add up to new approaches. Every year, we report on our incremental steps toward big-picture change; occasionally we are able to report that our achievements have resulted in paradigm shifts.

We are pleased and proud that this year we can report on major achievements in the big-picture sphere of policy reform – in the battle for Area C, in national policy for the Negev, in the fight against polygamy, the protection of the Judean Desert Nature Reserve and more. These significant achievements are the product of years of intensive activity and our partnerships with the government and the Knesset, regional and municipal councils, volunteers – and first and foremost, with you.


# **ACHIEVEMENTS**

#### A turning point in the battle for state land in Judea and Samaria!

The coalition agreement upon which the current government was formed included a key recommendation of Regavim's "Line in the Sand" Initiative: The Settlements Administration, headed by Treasury Minister Betzalel Smotrich, was established in the Ministry of Defense, leading to a dramatic shift in government planning and enforcement policy in Judea and Samaria.

In the final days of 2024, we completed our annual mapping project of illegal construction, which revealed with a drastic drop in the rate of illegal Arab construction in Area C.

Regavim has been fighting this war for nearly two decades, dedicating our research, lobbying, legal and media expertise to the protection of our national land resources, hand in hand with the municipalities of Judea and Samaria and other Zionist organizations. **Now, for the first time, our research indicates that the tide is turning; new illegal Arab construction has plummeted**. Although the government has a long, hard path ahead, the historic shift is noteworthy and encouraging.



#### FOCAL POINTS PROGRAM:TAKING BACK THE NEGEV

Equality Minister Social of Amichai Chikli, who heads the Settlement Bedouin and Development Authority, launched the government's Focal Points Program- based on the core principles of Regavim's Sde Boker Initiative. Significant strides have already been made, and we expect more progress as the plan gains momentum.



## **REGAVIM LEADS THE WAY: HISTORIC CHANGE IN THE DESERT**

For years, Regavim was a lone voice in the wilderness decrying the decimation of the Wye-designated Nature Reserve, a unique section of the Judean Desert entrusted to the Palestinian Authority – which has systematically destroyed it. We formed a coalition of forces, and this year, convinced the Israeli government to take long overdue steps to take back enforcement jurisdiction and protect the area. Enforcement has already begun, and we expect to see continued efforts that will repair and restore the desert ecosystem.



#### **UNRWA: UN(R)WANTED**

Justice is served: UNRWA, a terrorist organization hiding behind a humanitarian façade, has been banned from Israel! Together with other organizations and protest movements, Regavim has been fighting for years to expose UNRWA's anti-Israel activity, which intensified with the outbreak of the war, precipitating the decision to shut it down completely.





#### Groundbreaking Report: "Officers by Day, Terrorists by Night"

Our comprehensive report exposed the deep and ongoing involvement in terrorism of the Palestinian Authority Security Forces – funded, trained and armed by the US and European governments. Our report calls the very foundations of the "two state solution" into question, shining a spotlight on the true nature and motives of our "partner for peace." The report has sparked intensive discussion, particularly in the context of international pressure to recognize and empower a Palestinian state that would include the Gaza Strip.

# REGAVIM IN JERUSALEM



#### **NEW FIELD BRANCH**

Thanks to our dedicated partners, Regavim has come to Jerusalem, where our new field division focuses on land use, environmental protection and governance voids in Israel's eternal, undivided Capital.

#### THE JERUSALEM TERROR ENCLAVE

Kfar Akeb, the largest neighborhood in Israel that is home to more than 800 illegal buildings, is also a major exporter of terrorism. We lodged an official complaint with the Jerusalem Municipality, demanding enforcement against a multi-story building adjacent to the security barrier – and received a surprising reply: "We won't act, because enforcement here would mean enforcement against many hundreds of similar structures, and we're not up to the task." Regavim will continue to demand that the law, and our security, be protected.



#### **KILLING THE KIDRON VALLEY**

We exposed the monstrous, illegal – and profitable - garbage dump at Jerusalem's Arab a-Sawahra neighborhood in a YNET documentary, and sued those responsible for the ongoing health hazard caused by this environmental catastrophe.





#### THE LAST STRONGHOLD: MOUNT SCOPUS NATIONAL PARK

To bring the Mount Scopus area, which is the last remaining corridor to Jerusalem from the east, back onto the public agenda, we filed a series of complaints against illegal activity in this crucial area: an illegal scrapyard near A-Za'im, as well as 6 illegal garbage dumps in the A-Tur area.

#### ENFORCEMENT CHALLENGE: VILLAS FIRST

We filed complaints with the Jerusalem Municipality against a string of massive structures at strategic locations: one that creates a land-bridge connecting Jabel Mukaber and Ras al Amud, a cluster of villas on the road near Umm Tuba, an illegal mosque in Ras al Amud and more. Governance comes to the Capital!

#### Hosting MKs in the Field: Jerusalem

For the first time, we hosted a field tour of East Jerusalem for MKs, highlighting governance and land-use issues, the geographic and strategic connection between Maaleh Adumim, the Judean Desert and the heart of Jerusalem, construction and environmental hazards in the Capital's eastern neighborhoods, and the interface between an abandoned airport and a thriving vineyard.





In addition to our ongoing battle to protect the Land of Israel, Regavim received an emergency call to duty this year: We supported and assisted a number of grassroots initiatives over the course of the War of National Revival (Tekumah).

## STRENGTHENING BEREAVED FAMILIES AND FAMILIES OF HOSTAGES

We helped the Tikva Forum- Families of Hostages petition the High Court of Justice, and helped the Gevurah Forum of Bereaved Families petition the Regional Labor Court, to demand an immediate end to a general strike – an illegal attempt to bully the government into submission – on the grounds that it caused significant harm to all Israeli citizens and to particularly to the chances of freeing the hostages. The Labor Court upheld our petition and ordered an immediate end to the strike!

We applaud the Gevura Forum and the Tikva Forum for their strong and uncompromising stand, for their unwavering dedication to unity and social cohesion among Israeli citizens, and for their commitment to democracy. With them, we pray for the immediate return of all our hostages and for a decisive victory over our enemies.

#### **TZOFOT:** RESERVISTS' WIVES DEMAND HOMEFRONT SECURITY

A few weeks into the war, a forum of women came together when it became clear that despite the new realitiy surrounding them, Judea and Samaria were stuck in pre-October 7th security concepts. Wives and mothers stepped up, and Regavim stood behind them and beside them, helping launch their important home-front security initiative.

The name they chose – Tzofot – pays tribute to the young women lookouts of the IDF who fell in the line of duty. Like them, the new forum sought to become a brigade of women scouts who observe the situation at ground level and sound the warning alarm. "Tzofot" is active in media and parliamentary spheres, addressing homefront security issues and the challenges faced by reservists' families.





#### A NATION RISES UP: THE TZAV 9 PROTESTS

On Simchat Torah 5784, all Regavim employees were called up for extended reserve duty in various combat zones – including the battleground of Gaza, where we came face to face with the absurd and immoral transfer of hundreds of tons of supplies that ended up in the hands of Hamas, preventing a decisive victory and delaying the release of the hostages.

Together with the families of hostages and victims, reservists and evacuees of Gaza Envoelope communities, we assembled strong, clear-minded activists and launched the Tzav 9 Movement.

Support poured in from every segment of society for our peaceful, law abiding, respectful protest— from the kibbutzim and the cities, from both sides of the green line, religious and secular, "right" and "left".





When the Biden Administration and the EU imposed sanctions, we supported Tazv 9's leaders, Reut Ben Haim and Shlomo Sarid, in their media and legal battle, and initiated an important Knessest Foreign Affairs and Defense Committee hearing.

Eventually, in a joint decision with our dear friends, Tzav 9 embarked on an independent path and continues its important advocacy for complete victory and the return of our hostages.



#### THE PETITION THAT LED TO DEMOLITION

In recent years, "The Lieberman Road" in eastern Gush Etzion, connecting Tekoah to Jerusalem, has suffered a massive surge of illegal construction that forms a virtual choke-hold on the highway. We teamed up with the Land Division of the Gush Etzion Regional Council and petitioned the High Court of Justice against a two-story villa under construction only 100 meters from the highway.

In almost no time, a decision was handed down to demolish the structure.







#### **SMOKE CLOUDS THE HIGH COURT'S JUDGEMENT**


After years of complaints and lawsuits, we joined forces with the Binyamin Regional Council and filed a High Court petition – and at last, the Civil Administration demolished an illegal Palestinian Authority garbage dump near the Jewish communities of Migron and Kochav Yaakov – but in only a few weeks, the garbage, the stench and the horrific pollution began to pile up again, along with broken promises by the authorities. We went back to the High Court with a second petition against the dump, but the court were taken in by the Civil Administration's empty promises, and the air, water and soil pollution continue.





#### SAVING THE HAR HEBRON HERITAGE SITE

We've been in court for years with a series of petitions against Arab squatters who have decimated Khirbet Zanuta, an archaeological site in the Har Hebron area – but the saga took an unexpected turn when the squatters abandoned the site soon after the outbreak of the war, and a few weeks later. petitioned the HCJ, demanding IDF protection for their return to the site. The court upheld their petition, but we filed a counter-suit to block the absurd plan to enable the squatters' return. The judges changed course, and clarified that the squatters will not be permitted to damage the historic site.



#### THE (ILLEGAL) PARTY'S OVER

The events center located on the outskirts of Al-Khader adjacent to Route 60, the main traffic route connecting Gush Etzion to Jerusalem, is 100% illegal: It sits in an area under military noconstruction orders, and encroaches on an archaeological site. Regavim filed complaints for over a year, all of which were unanswered, so we took our demand to the High Court. The government promised to demolish the complex within 120 days, but the deadline has long passed and the compound continues to host events, so we're back in court.







#### WHY DID OC-CENTRAL COMMAND GRANT AN EXEMPTION?

Regavim and the Shomron Regional Council demanded immediate enforcement against an illegal structure on Route 55, in a military no-construction zone. We discovered that the Chief of Central Command exempted this structure from the noconstruction order, removing it from the enforcement agenda. We petitioned the High Court to clarify why this structure has been given preferential treatment— and to demand demolition.

#### "STOCKADE AND MINARET" HAS ITS DAY IN COURT

Two years ago we began to document illegal minarets that were popping up all over the Bedouin squatters camps of the Negev like mushrooms after the rain, symbolizing the growing lawlessness and religious extremism in Israeli Bedouin When society. our warnings and complaints to the authorities were unanswered, we petitioned the Beer Sheva District Court to force the government to act.

### THE HOSTILE VILLAGE'S HOSTILE TAKEOVER

We petitioned the High Court against 4 massive new structures built to the north of Karwat Bani Hasan in Samaria - but our petition was rejected: The High Court refused to grant a continuance even though our lawyer was in reserve duty. We will fight on...

## RESEARCH AND LEGISLATIVE ACTIVISM: REGAVIM'S POLICY DIVISION


#### **POSITION PAPERS**

This past year we published policy and position papers on a range of issues that are at the top of the public agenda: sanctions and embargoes imposed by foreign governements against Israeli citizens and organizations; registration of state land in strategic areas, among them, Nahal Heletz; a historical-legal review of the Umm al-Hiran case, and more. **Regavim's English-language policy library is fully accessible on our website.** 

#### **ACTIVE PARTICIPATION IN DOZENS OF KNESSET HEARINGS**

An important step in the battle against weapons theft We promoted legislation proposed by MK Yitzchak Kreuzer to expand military authority in the war against ammunition and weapons theft from IDF bases.





#### **UNRWA - OUT**

We took an active part in a Knesset Foreign Affairs and Defense Committee hearing that resulted in a ban on UNRWA: We presented a massive body of evidence, collected by Regavim's researchers over the course of years, proving that UNRWA is guilty of more than incitement: UNRWA was a full-fledged participant in the brutal attack launched on October 7th.



#### DANGEROUS ELECTRICITY LAW: DE- TABLED

To head off yet another attempt to pass an electricity law that would legalize thousands of illegal structures in the Arab sector, we launched an intensive media and lobbying campaign highlighting the legislation's inevitable results: encouraging illegal construction and decimating the rule of law. Thanks to the partnership of Ministers Orit Stock and Betzalel Smotrich, the bill was removed from the Knesset's legislative agenda.

#### BOMB SHELTER BOMBSHELL: EXPOSE'

In a Knesset sub-committee hearing, we presented the findings of our investigation: Former Homefront Command officers currently head a company subcontracted by the Ministry of Defense to produce mobile bomb shelters - in illegal factories in Judea and Samaria. As a result of our expose', the contracts were cancelled.


#### LESSONS OF OCTOBER 7TH: THE PA CONQUEST OF THE SEAMLINE

## CONQUEST OF THE SEAMLINE: FIELD RESEARCH DELIVERED DIRECTLY TO THE KNESSET

At the end of 2023, with the outbreak of the war and the collapse of the defensive "security barrier" concept, we published a report on the PA's takeover of the seam line buffer zone. The report received widespread attention and influenced public discourse throughout the year, and we followed up with field tours for MKs and dozens of Israeli and foreign journalists.

### THE ZIONIST, NATIONALIST VANGUARD Leading the Knesset land of Israel Caucus

We renewed the activity of the Knesset Land of Israel Caucus, under the co-chairmanship of MKs Yuli Edelstein, Limor Son-Har Melech and Simcha Rothman and with the participation of ministers, deputy ministers, mayors, governors and representatives of civil society organizations. The Caucus, the largest in the Knesset, leads Zionist legislation initiatives, parliamentary debates and public involvement and activism on key issues.



#### THE PEOPLE HAVE SPOKEN: NO TO A PALESTINIAN STATE

A historic Knesset decision rejecting the establishment of a Palestinian state in the heart of Israel was passed by a broad consensus of parties and an overwhelming majority of MKs. The decision, a joint initiative of Regavim and the co-chairs of the Land of Israel Caucus, sends a clear and unequivocal message to our enemies and a strong and empowering message to our soldiers.



#### SUPPORTING NORTHERN COMMUNITIES

Just before the ground campaign in the north began, we hosted members of the Knesset Land of Israel Caucus on a field tour along Israel's northern border that received extensive media coverage, bringing MKs together with municipal leaders and farmers to learn about the challenges and current needs of communites that have been on the front lines for over a year.

## FIELD DIVISION: JUDEA AND SAMARIA

### IT BEGAN WITH A WHATSAPP MESSAGE FROM AN ALERT CITIZEN

A resident of Adam noticed construction in an illegal cluster on the access road to his community. Our field coordinator investigated, documented and filed a complaint, in conjunction with the Binyamin Regional Council; the structure was demolished. Other illegal structures in the same cluster – all of them under pending demolition orders, including an illegal EU-sponsored school we petitioned about over a decade ago – remain.

#### THE STENCH OF HYPOCRISY

We sent an urgent demand for enforcement against a Palestinian Authority garbage dump adjacent to Karmei Tzur in Gush Etzion. In addition, we documented and reported a highly polluting dumping site north of Beit El that is choking the community with foul smells, toxic smoke and illegal construction.


#### TO MINISTER YOAV GALLANT: ABANDONING THE TERRITORY LEADS TO MURDER

We sent an urgent letter to outgoing Minister of Defense Yoav Galant and Chief of Central Command Major General Yehuda Fox demanding enforcement against dangerous illegal structures erected in the Talmonim bloc in Binyamin, on the ridge overlooking the "Horseshoe Junction" where a deadly shooting attack took place last March.









#### EXPOSE': THE PA'S NEW MUNICIPALITY – IN AN IDF TRAINING ZONE

We exposed another direct result of the abandonment of open spaces in Judea and Samaria – and IDF training grounds in particular: The PA published a celebratory announcement of its newest municipal authority in the Hebron Governate – in IDF Firing Zone 917.



#### CLOSING YOUR EYES IS NOT A PLAN

We exposed a large-scale landgrab spreading from the hostile Arab village of Duma in the Binyamin Region. New structures include multi-story residences, luxurious villas, large singlefamily homes and numrous commercial and agricultural structures. We opened a series of files and began to apply pressure on the authorities to halt further development and demolish illegal structures.



### THE PLAYERS HAVE TAKEN THE FIELD - LITERALLY

In the heart of the desert landscape in the southern Hebron Hills, near Eshkolot, we discovered a huge football field less than 100 meters away from the main traffic artery in the area but a significant distance away from the nearest Arab villages. Regavim's Legal Division has initiated procedures to reclaim the state land.

#### THE SIEGE OF JERUSALEM

The Palestinian Authority submitted a request to expand the village of Walaja in Gush Etzion on state land approved for development of Har Gilo, a nearby Jewish community. The PA's plan, which would connect Walajeh and Al-Khader and cut off the Jerusalem-Gush Etzion corridor. hasn't been approved, but work on the ground is already underway: bulldozers are clearing land, laying roads, and new buildings are going up, dangerously close to the road. pursuing immediate We are enforcement.

#### THE NAHALIN PALACE

Our field staff analyzed trends in illegal construction in the Beitar vicinity, and initiated proceedings against strategically-placed structures — some of them palatial villas — that hem in the Jewish community.









#### ILLEGAL ARAB CONSTRUCTION THREATENS AN IDF BASE

We exposed illegal Arab construction spreading from Dir Malik that is encroaching on the sole access road to the IDF's Baal Hazor base, a sensitive military installation located at the highest point in the Binyamin Region.

## FIELD DIVISION: NEGEV

#### CLEARING THE UMM AL HIRAN SQUATTERS CAMP: A SIGNIFICANT STEP FOR REGULATION OF THE NEGEV

In the context of Minister Chikli's Focal Proint Program, and with support from Ministers Strock and Ben Gvir, the Israel Land Authority and the Israel Police completed the evacuation of the Umm al Hiran squatters camp that has delayed the development of Dror, a new community approved more than two decades ago. We have been tracking and documenting this case for years, and our recently-updated position paper helped expose the false narratives and set the record straight.




#### FIGHTING CRIME IN THE NEGEV: A NEW POLICE UNIT AND OTHER BREAKTHROUGHS

As part of the effort to improve governance in the Negev, the Israel Police established a new specialized unit that will focus on organized crime, racketeering and illegal weapons in the Bedouin sector. The new unit and other recent enforcement activity are part of a campaign spearheaded by Minister Itamar Ben Gvir to bring security to the Negev.

#### WADI AL HALIL SQUATTERS CAMP EVACUATED

Years of delays finally came to an end and the cluster of Bedouin squatters that had invaded state land near the Shoket Junction and blocked the development of the southern branch of Route 6 (The Trans-Israel Highway) was finally cleared; the HCJ rejected the squatters' objections and upheld the states position.





#### 10 MINUTES IS ALL IT TAKES – 10 METERS FROM THE HIGHWAY

Regavim's new Zionist Planning Alliance and our southern region field coordinator traveled to the Negev to attend a Planning Commission hearing on plans for a new neighborhood, Al Bawadi, in the Bedouin town of Abu Tlul. What they saw and heard was shocking: after a 10minute discussion, the massive new neighborhood was approved for development: 11,500 dunams for a town of only 3,500 residents – only 10 meters away from Highway 25.

#### **"STOCKADE AND MINARET" EXPANDS**

We documented the tenth in a series of identical illegal mosques, this time near El Sayyid. Over the past two years, we've seen these cookie-cutter minarets spring up all over the Bedouin hinterlands of the Negev, but our complaints to the authorities have been fruitless, so we've taken the case to court.

#### THE CHAOS ON IDF BASES IN THE NEGEV HITS A NEW LOW

We've been sounding the alarm for years, but the theft of 18 shipping containers full of expensive military equipment from an IDF base in the Negev was beyond anything we've seen before, so we looked deeper: In addition to the judicial system's erosion of whatever deterrence may have existed, the IDF shut down the specialized unit that had been tasked with fighting the free for all on IDF training grounds.

#### **FIGHTING THE SANCTIONS**

Faced with the deafening silence of the Israeli government about the imposition of sanctions on Israeli citizens and organizations, we recruited a team of international lawyers who filed a petition against the American government in US Federal Court. The petition, which aroused great interest in Israel and around the world, seeks to cancel Executive Order 14115 on the grounds that the sanctions were imposed on law-abiding citizens without due process, in a discriminatory and draconian manner, and violate their basic civil rights.

#### **EU HYPOCRISY ON DISPLAY**

We learned that the EU is considering sanctions against Regavim, on the pretext that one of our petitions resulted in the court-ordered demolition of an illegal EUsponsored school in the Herodium Reserve. We took immediate action on a number of legal and political levels to head off the sanctions, and while no sanctions have yet been imposed, we continue to fight against the hypocrisy of foreian governments that are undermining Israel's sovereignty and the integrity of our judiciary.

#### WHEN DOES A MURDERER HIDE OUT IN A POLICE STATION?

A terrorist killed two IDF soldiers in a car-ramming attack, and escaped arrest by running straight into the arms of the Palestinian Authority Security Forces – another statistic for our growing dossier on "Officers by Day, Terrorists by Night," the Regavim report that continues to impact public opinion.

#### BEDOUISTAN: PUBLICITY AND MEDIA PRESSURE WORK!

We flooded the media with news that the IDF had disbanded the special unit tasked with protecting IDF bases in the Negev – resulting in a wave of theft and drug trafficking. As a result of the wide coverage of the story, the IDF reinstated the unit.



#### THE FAILED CONCEPT - STILL ALIVE AND KICKING, 5 MINUTES FROM BEN GURION AIRPORT

Regavim's Director General, Meir Deutsch, spoke at the Besheva Group's annual Sderot Conference, and explained "the conception," the failed paradigm that continues to shape security and political policy in Judea and Samaria and the Negev, and detailed the steps Israel's leaders must take – immediately - to replace the failed concepts.
